

# APPLYING THE WARTEGG TO THE COMPLEX CASE OF A BICULTURAL YOUTH

This workshop presents a case study of an 8-year-old bicultural student undergoing a comprehensive psychological assessment. The session will explore the clinical application and utility of the Wartegg Drawing Completion Test (WDCT) in understanding the child's developing personality, defense mechanisms, and adaptive behaviors.

Dr. Palm will lead a live supervision and consultation, facilitating an in-depth discussion on the interpretation of the case. Special attention will be given to the influence of bicultural factors on assessment results, focusing on both universal and culturally specific interpretations.

Participants will also explore how to formulate individualized treatment plans and recommendations based on the assessment, with a nuanced understanding of cultural differences that impact psychological evaluations.

This workshop is ideal for mental health professionals who work with diverse populations and are interested in enhancing their skills in culturally sensitive psychological assessments and interventions.

Jacob A. Palm, Ph.D., serves as the founder and director of the Southern California Center for Collaborative Assessment. He is the United States representative of the Istituto Italiano Wartegg in Rome, Italy, where he works closely with Dr. Alessandro Crisi on clinical applications, research, and training of the Wartegg Drawing Completion Test. Dr. Palm is co-author of the English-language handbook on the administration, scoring, and interpretation of the Wartegg according to the Crisi Wartegg System (CWS). Dr. Palm is on staff at Miller Children's Hospital at Long Beach Memorial and provides assessment consultation to various programs throughout the southern California area, including the Promises Treatment Centers. He provides integrated assessments as a member of the Teen Brain Team at Hoag-Presbyterian Hospital, Neurosciences Institute (Newport Beach). Dr. Palm completed his doctorate at Fordham University, in the Bronx, New York. He has previously served as the Director of APA Internship Training and Director of Psychological Assessment for The Guidance Center, a community mental health center, in Long Beach, California.

**Dr. Leighko Toyoshima Yap** is a licensed clinical and forensic psychologist who specializes in the treatment of children and the psychological assessment of children, adolescents, and adults for more than 20 years.
